

## 2020 "LIVE UNITED" Volunteer Scholarship Awards Criteria

United Way of Addison County fosters community service in all community members, but especially in our youth. In that spirit we will be honoring class of 2020 Addison County students at their awards nights. The purpose of this scholarship is to recognize high school seniors who volunteer in their community who are interested in advancing their education.

On behalf of a generous donor, three senior high school students will be chosen for the "LIVE UNITED" Volunteer Scholarship Award. This award comes with a \$1,000 cash award for each student, to be used for post-graduation education. This could be college, trade school, Adult Education, etc. Applicants who are not selected for this award will be recognized and receive a certificate of appreciation for their contribution to our community.

### Eligibility

Applications for the "LIVE UNITED" Volunteer Scholarship Award can be submitted to the United Way of Addison County if the nominee meets the following criteria:

- 1. Addison County Senior in High School (or equivalent)
- 2. 21 years old or younger
- 3. Has volunteered in Addison County within the 2019-2020 school year (7/1/19 to present)
- 4. The volunteer service has made an impact on a non-profit organization, its clients, the community, and their own personal learning
- 5. Must be applying or enrolled in an accredited post-graduation site. This could be college, trade school, Adult Education (minimum 6-credit semester or the equivalent)
- 6. Participation in this scholarship award shall be on a voluntary basis

### Requirements

- 1. Completed Scholarship Application
- 2. Letter of reference from organization where you volunteer that answers attached questions
- 3. The scholarship funds will be made available to the educational institution to which the student is enrolled
- 4. Payment will be issued by the United Way Addison County

### Selection and Schedule

No applications will be accepted after this date. Upon receipt of your application you will receive a confirmation email. Scholarship recipients will be notified by United Way of Addison County.

NOTE: All applications will be judged by a selection panel. Scholarships will be awarded based upon the applicant's volunteer work and reference. UWAC reserves the right to discontinue this scholarship program at any time without notice. UWAC reserves the right to withhold scholarship awards if there are no qualified applicants.
